### **FAQ For Wealth For The Workers**

#### 1. Activate: What does it mean?

This means you or someone in your team now have a minimum of 62 Members, (who all must activate with you.)

"Activate" means that you will be filling out and sending the form in from the WFTW website that notified your credit card or PayPal that the monthly payments for the E.Books will begin on the 10<sup>th</sup> of each month and will need to be paid into the Wealth For The Workers' bank account no later than the 10<sup>th</sup> of each month.

The payment method is a direct debit to come from a credit card or PayPal.

If you do not own a credit (/debit) card you can obtain one from most supermarkets and put the monthly E.Book payments onto that credit card. (No credit checks are needed in order to obtain a credit card from these Supermarkets.)

This Activate step is hugely IMPORTANT for you and everyone in your team so that the products you have been waiting for and the entitlements that you will receive can begin.

If this step is ignored, delayed or neglected entitlements cannot be paid out.

### 2. What does my first payment include?

After the first month, the only fee paid is the E. Book Product fee of \$137.50 which is due at the  $10^{th}$  of each month, (except for the yearly admin fee payment.)

PLEASE NOTE: the yearly admin fee will be charged once a year, so please make allowances once per year in the month you started in

Wealth For The Workers.

#### 3. How can I promote my new business?

You can download the E.Catalogue from the Wealth For The Workers' Website and show your friends and family members the amazing E.Books and wealth of knowledge that is in these E.Books.

After your friends or family like what they are see, they may agree to either become a customer for you, where you receive an entitlement for the sale of the E.Books, or they may ask about the business side of Wealth For The Workers and then you can tell them about the Business Opportunity.

Always lead in with the E.Books. Make sure you are familiar with the E.Catalogue and have some spare copies with you at all times. You will get a copy of the E.Catalogue from the Wealth For The Workers' website.

### 8. How much do I get paid as an author?

Currently authors are paid \$10 (includes gst) per sale of their E.Books through the Wealth For The Workers Program.

9. Can I be a Member of Wealth For The Workers' Business Opportunity and also be an Author for the Wealth For The Workers' E.Catalogue?

Definitely Yes. Write to <a href="mailto:cath@thegoodnewsnp.com.au">cath@thegoodnewsnp.com.au</a> and submit your E.Book for appraisal for the E.Catalogue.

#### 10. How am I paid as an author?

As an Author, you will be advised on the number of E.Book sales of your E.Book monthly.

The sales for the E.Books will be for one calendar month from the 10<sup>th</sup> of the month to the 9<sup>th</sup> of the new month.

After notification of the number of book sales for that month, you will invoice Wealth For The Workers for the number of book sales that you have been advised X \$10.

For example, if your E.Book has made 100 book sales, you will be paid \$1,000 so your invoice will show:

100 (name of E.Book and author's name in full ) X \$10 = \$1,000.(incl. gst)

An example of the Tax Invoice will be on the Authors' Tab on the Wealth For The Workers' website, so please follow the example of that invoice.

### 11. What types of E.Books are accepted in the E.Catalogue?

Wealth For The Workers will accept most genres both fact and fiction. The only books that will not be included in the catalogue will be: X Rated or R Rated sex books, pornographic books, any books that depict unnecessary cruelty, torture, horror or violation of human rights, literally any extreme topics will not be accepted.

Every book will be checked for its content.

#### 12. How can I advertise my business opportunity?

If you wish to advertise yourself in any media outlet anywhere, you must submit any of these advertisements of any nature to Wealth For The Workers' Head Office for approval.

There will be acceptable guidelines posted up on the Wealth For The Workers' website which can be used and downloaded, however, any advertisements which are different from the ones that are recommended by Wealth For The Workers must have PRIOR written approval before they can be released to any of the media outlets or social media or published with the purpose of promotion.

# 13. What are some ways I can promote the business side of Wealth For The Workers?

You can mainly talk to your friends and family.

You will have a Starter Kit, with tools in there to promote your business, such as the E.Catalogue. This E.Catalogue will also be found on the Wealth For The Workers' website.

You should also attend training sessions either at weekly meetings, monthly meetings, conventions, or over the phone meetings from your Team. You can also download forms and information from the Wealth For The Worker's website.

You can learn how to promote your business also from online meetings, webinars and seminars.

- 14. There will be weekly team webinars which you can send family, friends and other people who you have contacted about the opportunity.
- 15. What if I am having difficulties with promoting this Wealth For The Workers' business opportunity?
